### SIEF Information Letter 3 Synthetic Amorphous Calcium Silicate (CS): LoA Agreement / -Cost

Dear SIEF members,

With this SIEF Information Letter the SASFORREACH Consortium (“Consortium”) would like to inform all SIEF members about the agreement and the cost for the joint registration of

#### **Synthetic Amorphous Calcium Silicate (CS), EC # 215-710-8, CAS # 1344-95-2**

The price for the letter of access (“LoA”) to the joint registration dossier for **Synthetic Amorphous Calcium Silicate (“CS”)** depends on the tonnage band for which a registration is made and has been calculated on a preliminary basis as follows:

1000+t/a	€ 42,000 (including read across fee for SAS)
100 - 1000t/a:	€ 42,000 (including read across fee for SAS)
10 - 100t/a:	€ 19,000 (including read across fee for SAS on needed data, reduced read across fee)
1 - 10t/a:	€ 6,000

Please bear in mind that every study/action which is listed in the cost calculation document was necessary for the successful registration of

Synthetic Amorphous Calcium Silicate (CS), EC # 215-710-8, CAS # 1344-95-2,

thus the price of the letter of access is not negotiable. Likewise, the LoA agreement defining the terms and conditions under which a letter of access will be issued is a standard document.

As the Consortium expects less than 2 potential registrants to join the joint submission for

in the highest tonnage band, no rebate in case of additional buyers is planned. The Consortium will ensure full compliance with applicable REACH and other EU legislation.

After receipt of payment for the LoA, the lead registrant will provide purchasers of a LoA with a complete registration package, including a Letter of Access to the technical part of the dossier (parts 4 – 13 and the Chemical Safety Report).

For **CS** the Guidance on safe use (chapter 11) is submitted jointly on behalf of all consortia members. Therefore it is possible that all further co-registrants can refer to this document.

The Consortium will ensure full compliance with applicable REACH and other EU legislation.

The Consortium published some info and a short guidance for the registration of **CS** on the homepage of the Consortium [<http://www.reach-sas.org/>].

**Please also note that the costs for the LoA could only be calculated on a preliminary basis at this time, thus a final calculation may lead to additional charges or reimbursements. A final calculation will be prepared after the expiry of the last REACH registration deadline in 2018 and all purchasers of a LoA will be billed for outstanding costs.**
